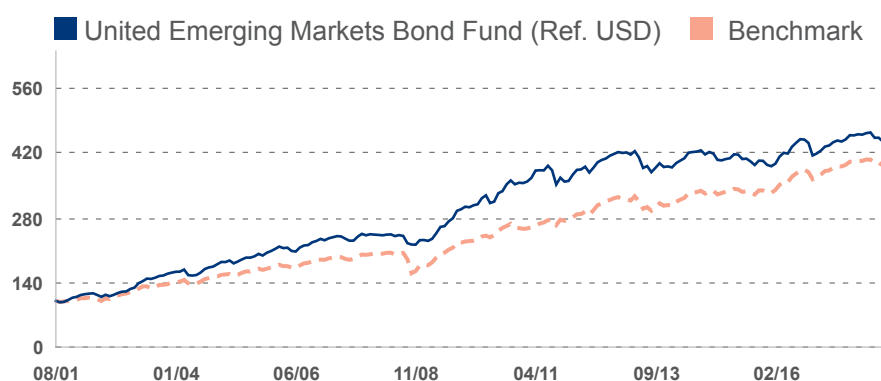


# United Emerging Markets Bond Fund (Ref. USD)

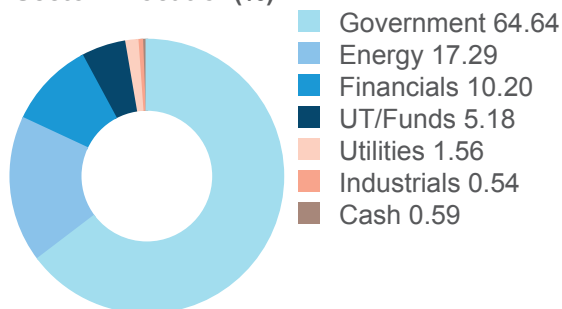

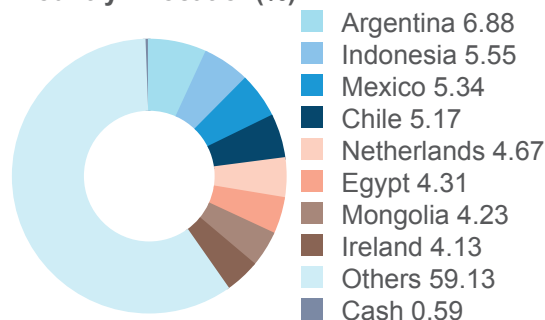
