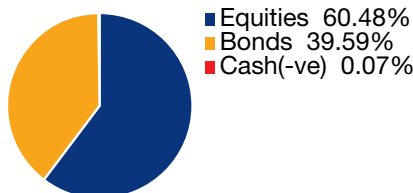
Fund Objective

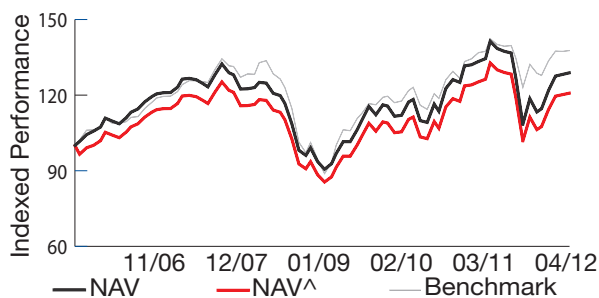
