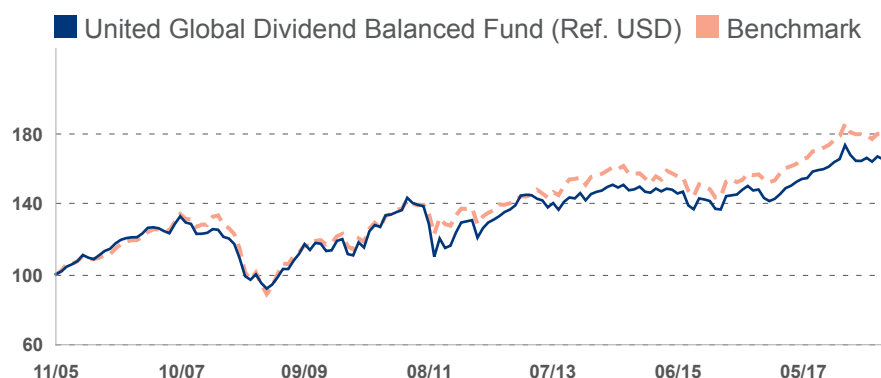


United Global Dividend Balanced Fund (Ref. USD)

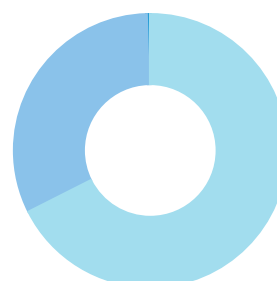
