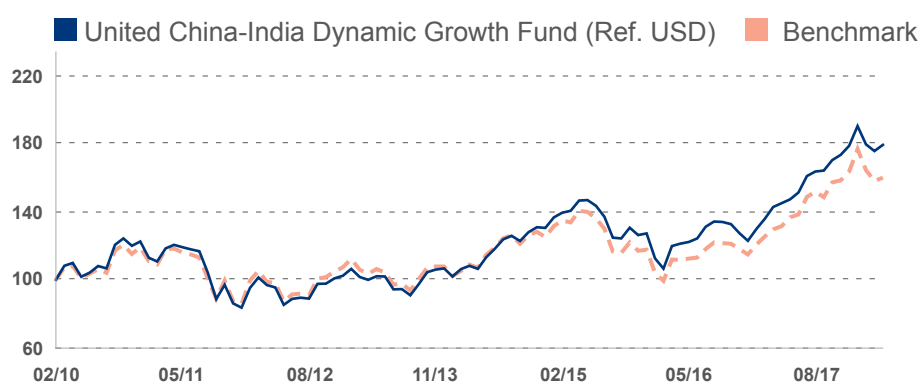


United China-India Dynamic Growth Fund (Ref. USD)

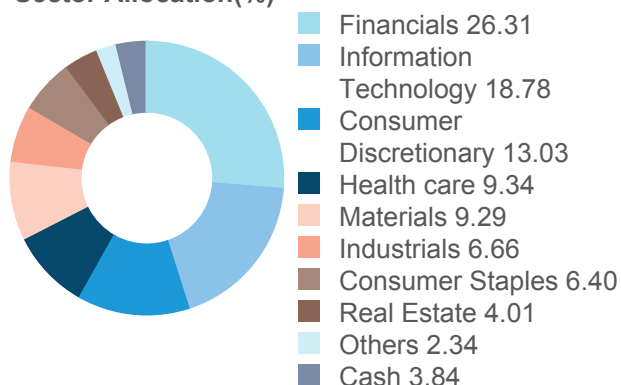

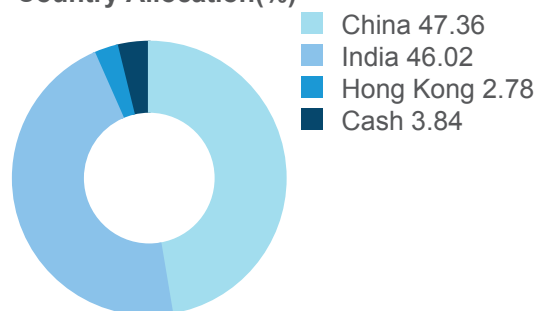
