

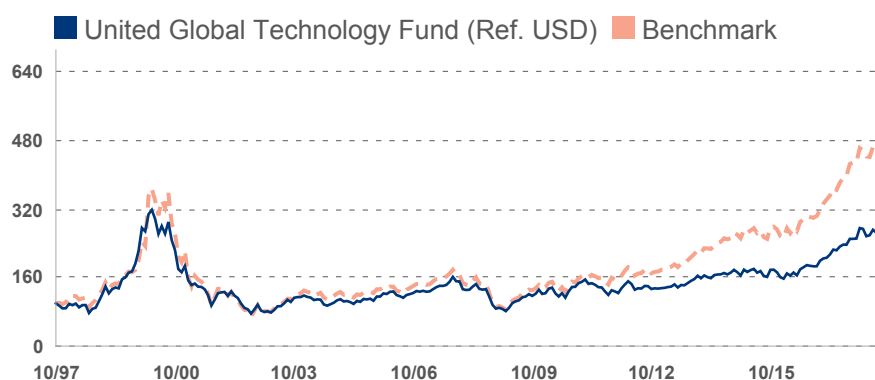
United Global Technology Fund

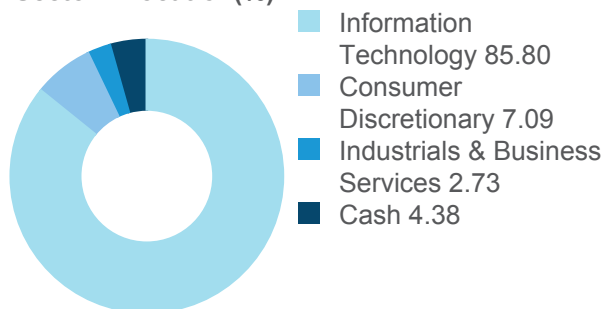

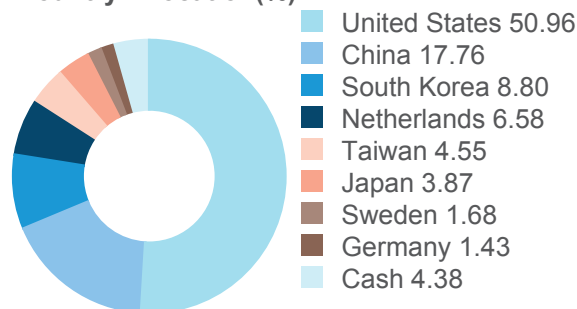
