

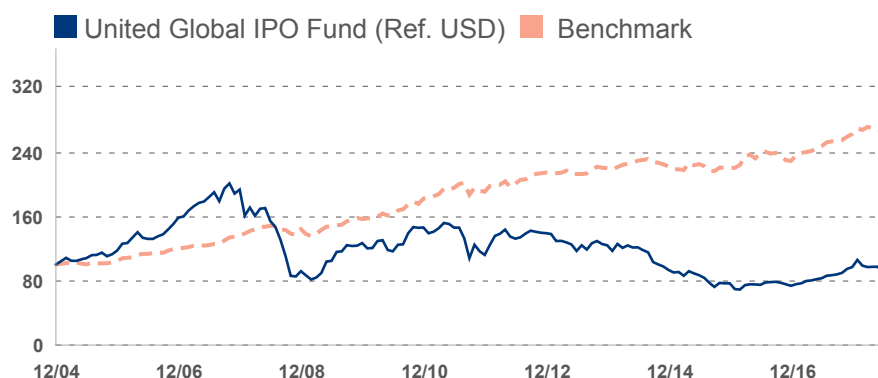
United Global IPO Fund

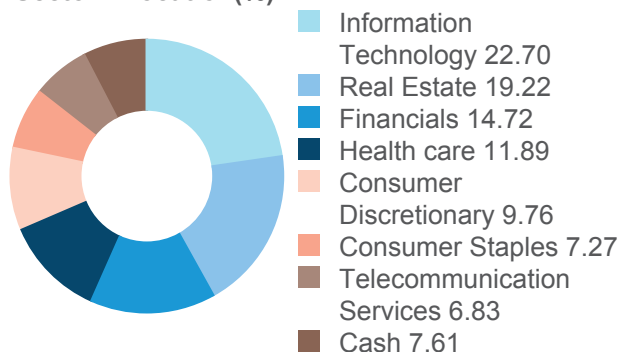

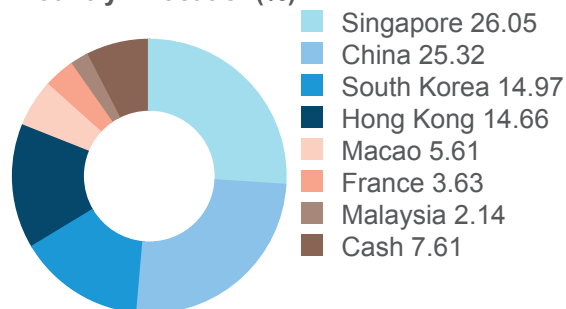
