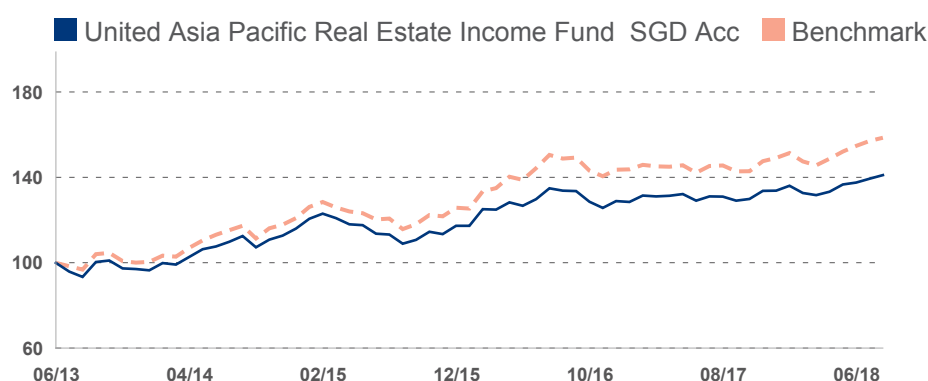


United Asia Pacific Real Estate Income Fund

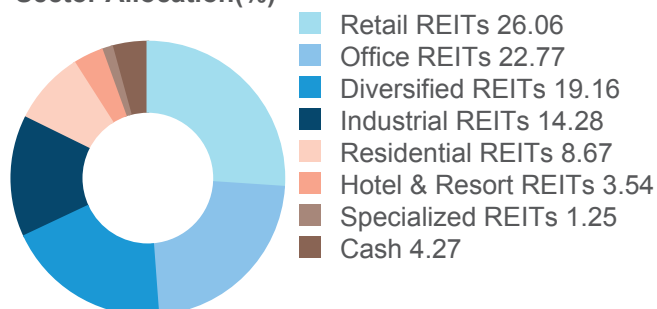

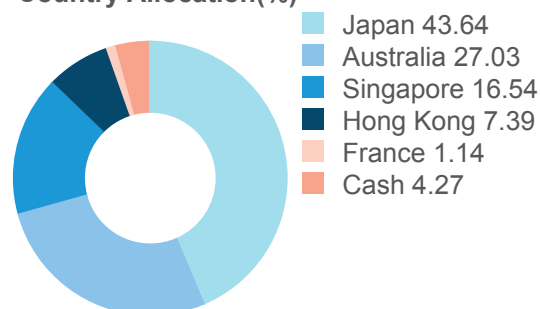
