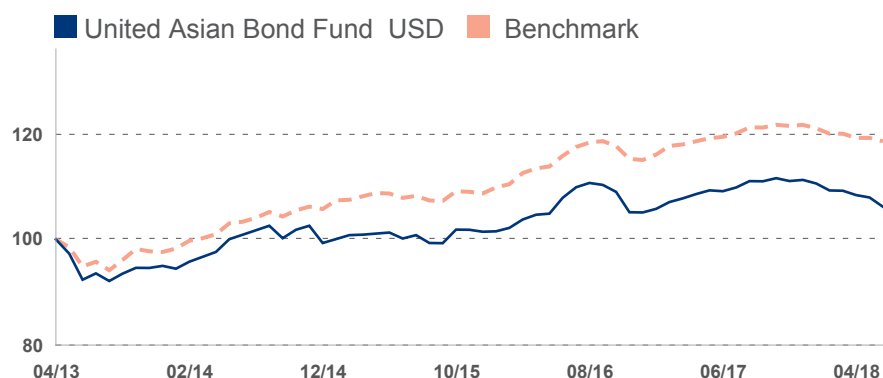


United Asian Bond Fund

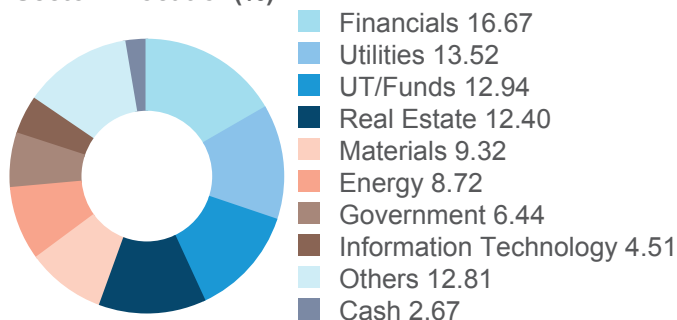

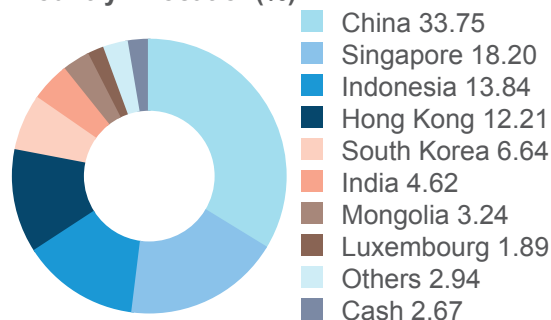
