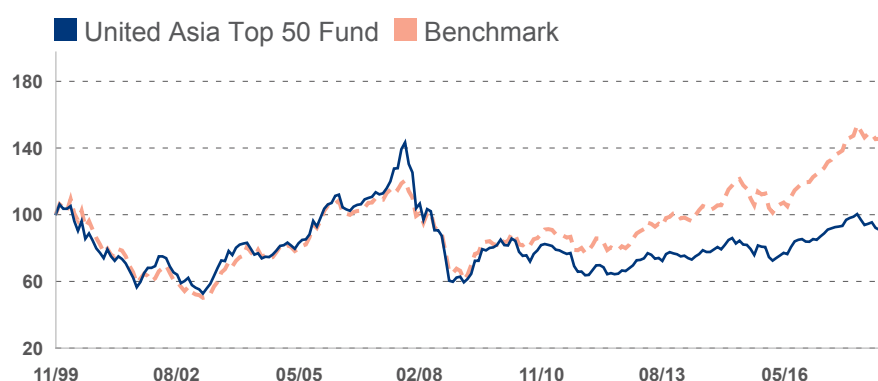


United Asia Top 50 Fund

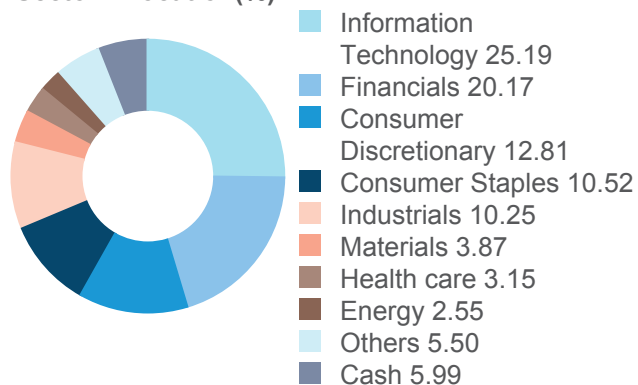

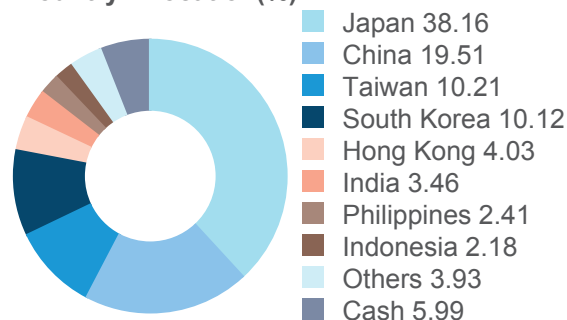
