Fund Objective

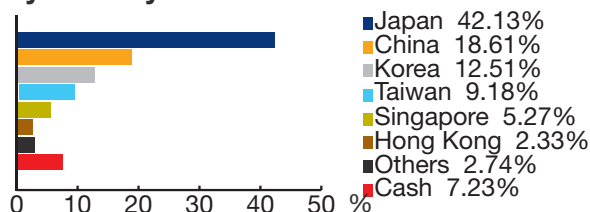

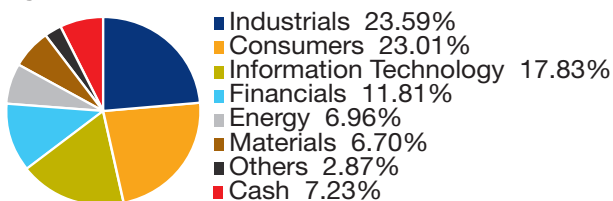

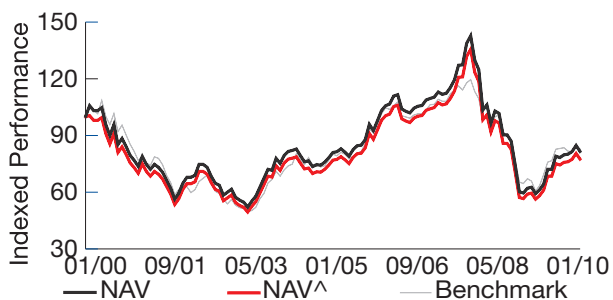
