Fund Objective

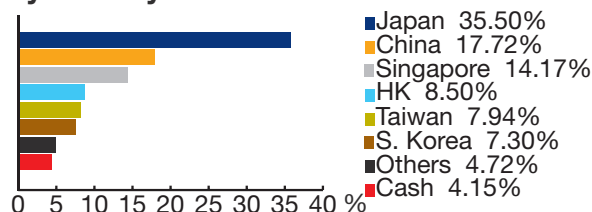

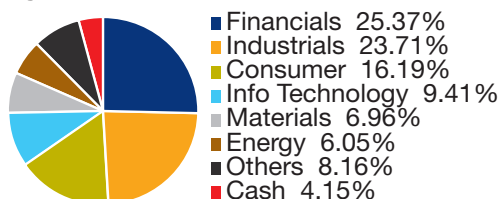

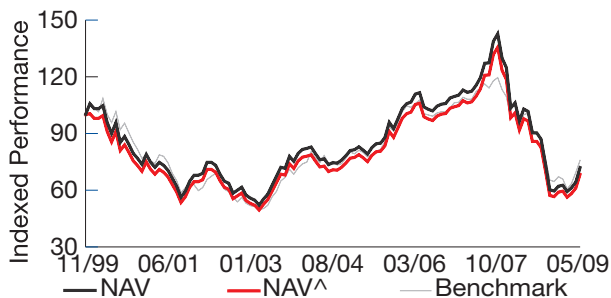
