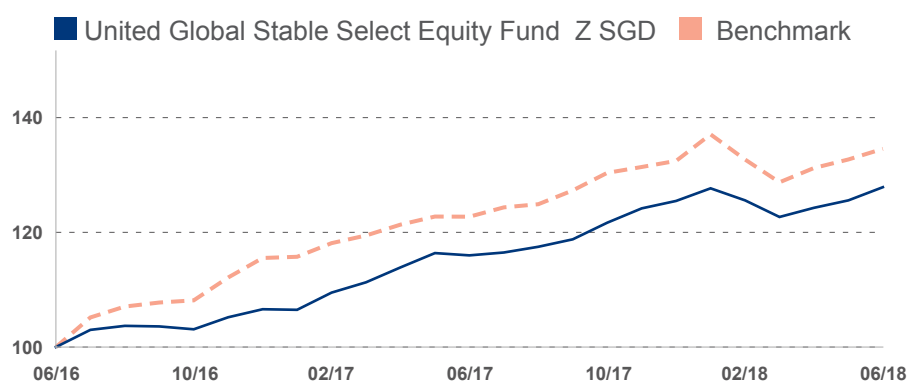


United Global Stable Select Equity Fund

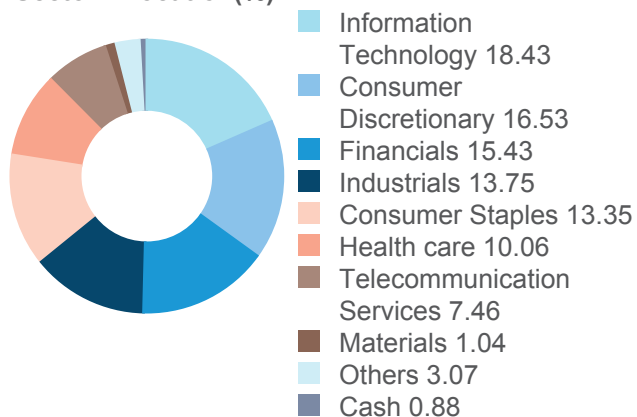

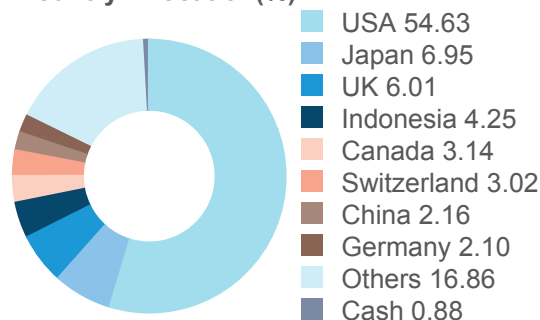
