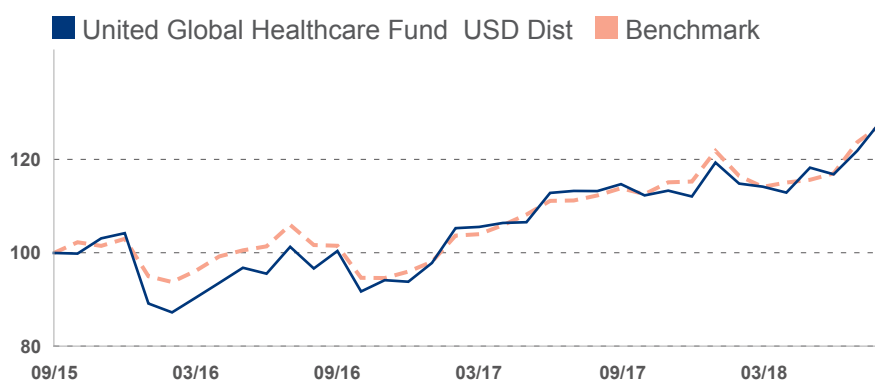


United Global Healthcare Fund

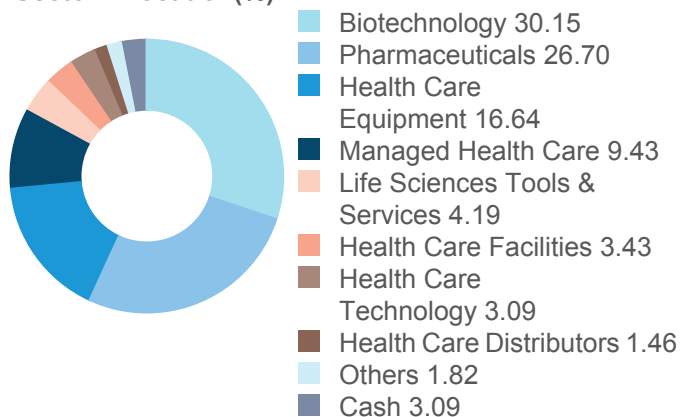

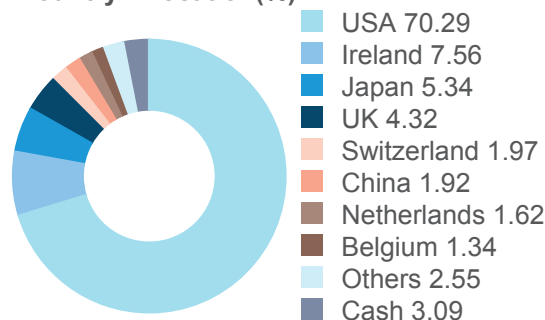
