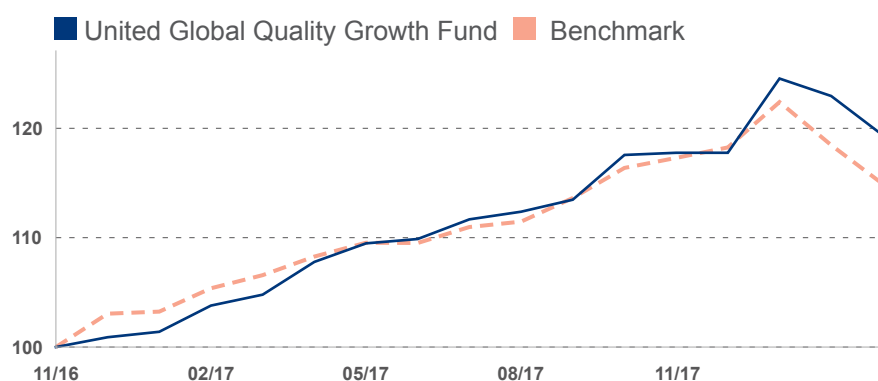


United Global Quality Growth Fund

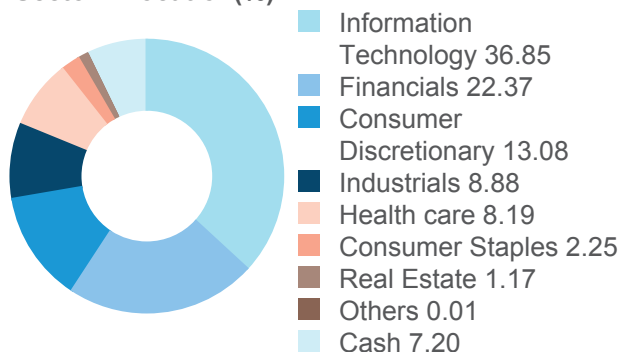

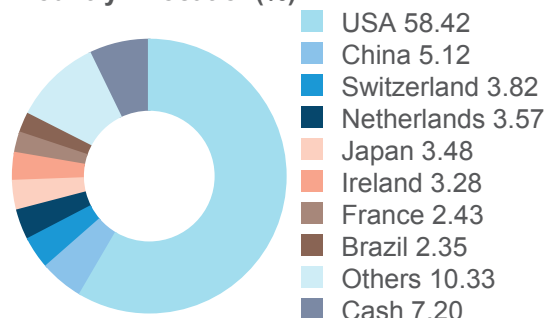
